Section 2: Hazards Identification

- **Classification (GHS):** Flammable Liquid (Category 3), Skin Irritant (Category 2), Eye Irritant (Category 2A).
- **Signal Word:** Warning
- **Hazard Statements:**
 - Flammable liquid and vapor
 - Causes skin irritation

Section 4: First Aid Measures

- **Inhalation:** Move to fresh air. If symptoms occur, seek medical attention.
- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical advice if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Seek immediate medical attention if irritation persists.
- **Ingestion:** Rinse mouth. Do not induce vomiting. Seek immediate medical advice.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Vapors may form explosive mixtures with air. Emits toxic fumes of carbon oxides under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

- **Storage:** Store in tightly closed containers in a cool, dry, well-ventilated place. Protect from direct sunlight and heat.

- **Stability:** Stable under normal conditions.
