- **Synonyms:** n-Octyl Alcohol, 1-Octanol

Section 3: Composition / Information on Ingredients

- **Chemical Name:** 1-Octanol
- **CAS No:** 111-87-5
- **Concentration:** $\geq 95\%$

Section 4: First Aid Measures

- **Inhalation:** Move to fresh air. If symptoms occur, seek medical attention.
- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing.
- **Eye Contact:** Rinse cautiously with water for several minutes. Seek medical advice if irritation persists.
- **Ingestion:** Rinse mouth. Do not induce vomiting. Seek immediate medical advice.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Emits toxic fumes of carbon oxides under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid inhalation and skin/eye contact. Ensure adequate ventilation.
