Section 1: Product Identification

- **Product Name:** Ethyl Propionate
- **Chemical Formula:** C₅H₁₀O₂
- **CAS No:** 105-37-3
- **Synonyms:** Propionic acid ethyl ester; Ethyl propanoate
- **Recommended Use:** Flavoring agent; fragrance ingredient; laboratory chemical/intermediate.

Section 3: Composition / Information on Ingredients

- **Concentration:** 100%

Section 4: First Aid Measures

- **Inhalation:** Remove to fresh air. If symptoms develop, seek medical attention.
- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical advice if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Get medical attention if irritation persists.
- **Ingestion:** Rinse mouth. Do not induce vomiting. Seek medical advice if unwell.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Dry chemical, foam, carbon dioxide (CO₂); water spray.
- **Specific Hazards:** Highly flammable liquid and vapor; emits toxic fumes of carbon oxides under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid breathing vapors. Ensure adequate ventilation. Eliminate ignition sources.
- **Environmental Precautions:** Prevent entry into drains and waterways.
- **Cleanup Methods:** Absorb with inert material (sand, earth). Collect in suitable container for disposal.

Section 7: Handling and Storage

- **Handling:** Avoid inhalation of vapors and contact with skin/eyes. Use with adequate ventilation. Keep away from ignition sources.
- **Storage:** Keep container tightly closed. Store in a cool, dry, well-ventilated place away from heat and oxidizing agents.

Section 8: Exposure Controls / Personal Protection

- **Exposure Limits:** OSHA PEL 400 ppm (TWA); ACGIH TLV 400 ppm (TWA).
- **Engineering Controls:** Provide adequate ventilation and local exhaust if needed.
- **Personal Protective Equipment:** Chemical-resistant gloves, safety goggles, protective clothing. Respirator if ventilation is inadequate.

Section 9: Physical and Chemical Properties

- **Appearance:** Colorless liquid
- **Odor:** Fruity, pineapple-like odor
- **Boiling Point:** 99 °C
- **Flash Point:** 12 °C (closed cup)
- **Solubility:** Slightly soluble in water; miscible with ethanol and organic solvents
- **Molecular Weight:** 102.13 g/mol

Section 10: Stability and Reactivity

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.

- **Routes of Exposure:** Inhalation, ingestion, skin and eye contact.
- **Acute Effects:** Causes skin and eye irritation; may cause respiratory irritation.
