Section 3: Composition / Information on Ingredients

- **Concentration:** 100%

Section 4: First Aid Measures

- **Inhalation:** Remove to fresh air. If symptoms develop, seek medical attention.
- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical advice if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Remove contact lenses if present. Get medical attention if irritation persists.
- **Ingestion:** Rinse mouth. Do NOT induce vomiting. Seek medical advice if unwell.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Dry chemical, foam, carbon dioxide (CO₂); water spray for cooling.
- **Specific Hazards:** Flammable liquid and vapor; vapors may form explosive mixtures with air. Combustion produces carbon oxides.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Eliminate ignition sources. Ensure adequate ventilation.
- **Environmental Precautions:** Prevent entry into drains and waterways.
- **Cleanup Methods:** Absorb with inert material (sand, earth). Collect in suitable container for disposal.

Section 7: Handling and Storage

- **Handling:** Avoid inhalation of vapors and contact with skin/eyes. Use in well-ventilated areas. Ground and bond containers.
- **Storage:** Keep container tightly closed. Store in a cool, dry, well-ventilated place away from heat, sparks, and open flames.

- **Exposure Limits:** 100 ppm (350 mg/m³); ACGIH TLV: 50 ppm (TWA).
- **Engineering Controls:** Provide adequate ventilation and local exhaust if necessary.
- **Personal Protective Equipment:** Chemical-resistant gloves, safety goggles, protective clothing. Respiratory protection if ventilation is inadequate.

- **Appearance:** Colorless liquid
- **Odor:** Alcohol-like odor
- **Boiling Point:** 102 °C
- **Flash Point:** 40 °C (closed cup)
- **Solubility:** Slightly soluble in water; miscible with alcohol and organic solvents

- **Stability:** Stable under normal conditions.
