- **Concentration:** >95% Thioacetic Acid

Section 4: First Aid Measures

- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical advice if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Seek medical attention if irritation persists.

- **Ingestion:** Rinse mouth. Do not induce vomiting. Seek immediate medical advice.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Emits toxic fumes of sulfur oxides and carbon oxides under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.
