Section 1: Product Identification

- **Product Name:** Jasmone
- **Chemical Formula:** C₁₁H₁₆O
- **CAS No:** 488-10-8
- **Synonyms:** cis-Jasmone; 3-Methyl-2-(pent-2-enyl)cyclopent-2-en-1-one
- **Recommended Use:** Used in fragrance formulations, cosmetics, and as an intermediate in organic synthesis.

Section 2: Hazards Identification

- **Classification (GHS):** Skin Irritant (Category 2); Eye Irritant (Category 2A); Skin Sensitizer (Category 1B); Aquatic Chronic Hazard (Category 2)
- **Signal Word:** Warning
- **Hazard Statements:**

Section 3: Composition / Information on Ingredients

- **Concentration:** $\geq 95\%$
