Section 1: Product Identification

- **Product Name:** 2-Chlorobenzaldehyde
- **Chemical Formula:** C₇H₅ClO
- **CAS No:** 89-98-5
- **Synonyms:** o-Chlorobenzaldehyde; Benzaldehyde, 2-chloro-
- **Recommended Use:** Laboratory chemical; intermediate in organic synthesis.

Section 2: Hazards Identification

- **Classification (GHS):** Acute toxicity, Oral (Category 4); Skin irritation (Category 2); Eye irritation (Category 2A).
- **Signal Word:** Warning
- **Hazard Statements:**

- Harmful if swallowed
- Causes skin irritation
- Causes serious eye irritation
- Wash thoroughly after handling
- Wear protective gloves/eye protection
- **IF ON SKIN or IN EYES:** Rinse cautiously with water; seek medical advice if irritation persists

Section 3: Composition / Information on Ingredients

- **Concentration:** 100%

Section 4: First Aid Measures

- **Inhalation:** Remove to fresh air. If symptoms develop, seek medical attention.
- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical advice if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Get medical attention if irritation persists.
- **Ingestion:** Rinse mouth. Do NOT induce vomiting. Seek medical advice if unwell.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Dry chemical, foam, carbon dioxide (CO₂); water spray.
- **Specific Hazards:** Emits toxic fumes of carbon oxides and hydrogen chloride under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid breathing vapors. Ensure adequate ventilation.
- **Environmental Precautions:** Prevent entry into drains and waterways.
- **Cleanup Methods:** Absorb with inert material (sand, earth). Collect in suitable container for disposal.

- **Handling:** Avoid inhalation of vapors and contact with skin/eyes. Use with adequate ventilation.
- **Storage:** Keep container tightly closed. Store in a cool, dry, well-ventilated place away from heat and oxidizing agents.

- **Stability:** Stable under normal conditions.
