- **Product Name:** Ethyl Linalool
- **Chemical Formula:** C₁₂H₂₂O
- **CAS No:** 10339-55-6
- **Synonyms:** 3,7-Dimethylocta-1,6-dien-3-ol, ethyl ether
- **Recommended Use** Used as a fragrance ingredient in perfumes, cosmetics, and personal care products.

- **Concentration:** 95%

- **Stability:** Stable under normal conditions.
