- **Product Name:** 2-Phenoxyethanol
- **Chemical Formula:** C₈H₁₀O₂
- **CAS No:** 122-99-6
- **Synonyms:** Ethylene glycol monophenyl ether; Phenoxytol
- **Recommended Use:** Laboratory chemical; preservative in cosmetics and pharmaceuticals; solvent; antimicrobial agent.

Section 4: First Aid Measures

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid breathing vapors. Ensure adequate ventilation.
- **Environmental Precautions:** Prevent entry into drains and waterways.
- **Cleanup Methods:** Absorb with inert material (sand, earth). Collect in suitable container for disposal.

- **Appearance:** Colorless to pale yellow liquid

- **Stability:** Stable under normal conditions.
