Section 1: Product Identification

- **Product Name:** 2-Phenylethanol
- **Chemical Formula:** C₈H₁₀O
- **CAS No:** 60-12-8
- **Synonyms:** Phenethyl alcohol; β -Phenylethanol
- **Recommended Use:** Laboratory chemical; fragrance ingredient in perfumes, cosmetics, and soaps; flavoring agent; intermediate in organic synthesis.

Section 4: First Aid Measures
