Section 1: Product Identification

Section 2: Hazards Identification

- **Classification (GHS):** Eye Irritant (Category 2A).
- **Signal Word:** Warning
- **Hazard Statements:**
 - Causes serious eye irritation
- **Precautionary Statements:**
 - Avoid contact with eyes
 - Wear protective gloves and eye protection
 - Wash hands thoroughly after handling

Section 3: Composition / Information on Ingredients

- **Chemical Name:** Ethylene Glycol Diacetate
- **Synonyms:** EGDA, 1,2-Ethanediol diacetate
- **CAS Number:** 111-55-7
- **Concentration:** >98%

Section 4: First Aid Measures

- **Inhalation:** Remove to fresh air. If symptoms occur, seek medical attention.

- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical advice if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Seek immediate medical attention if irritation persists.
- **Ingestion:** Rinse mouth. Do NOT induce vomiting. Seek immediate medical advice.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Water spray, alcohol-resistant foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Emits toxic fumes of carbon oxides under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid inhalation and skin/eye contact. Ensure adequate ventilation.
- **Environmental Precautions:** Prevent entry into drains, surface water, and soil.
