Section 1: Product Identification

- **Product Name:** Methyl Propionate
- **Chemical Formula:** C₄H₈O₂
- **CAS No:** 554-12-1
- **Synonyms:** Propanoic acid, methyl ester; Methyl propanoate
- **Recommended Use** Solvent, intermediate in organic synthesis, and used in flavors, fragrances, and as a plasticizer.

- **Concentration:** >95%

Section 4: First Aid Measures
