- **Product Name:** Methyl Heptenone
- **Chemical Formula:** C₈H₁₄O
- **CAS No:** 110-93-0
- **Synonyms:** 6-Methyl-5-hepten-2-one, 2-Hepten-6-one, 6-methyl-
- **Recommended Use** Used as a fragrance ingredient, flavoring agent, and intermediate in organic synthesis.

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents, strong acids and bases.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.
