Section 1: Product Identification

- **Product Name:** Isophorone
- **Chemical Formula:** C₉H₁₄O
- **CAS No:** 78-59-1
- **Synonyms:** 3,5,5-Trimethyl-2-cyclohexen-1-one
- **Recommended Use** Used as a solvent in coatings, inks, adhesives, and in organic synthesis.
