Section 1: Product Identification

- **Product Name:** Dihydromyrcene
- **Chemical Formula:** C₁₀H₁₈
- **CAS No:** 2436-90-0
- **Synonyms:** 2,6-Dimethyl-2,7-octadiene
- **Recommended Use** Used in perfumery, as a fragrance intermediate, and in flavor compositions.

Section 4: First Aid Measures

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Emits toxic fumes of carbon oxides under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid inhalation and skin/eye contact. Ensure adequate ventilation.

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents, strong acids and bases.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.
