Section 1: Product Identification

- **Product Name:** Methyl Salicylate
- **Chemical Formula:** C₈H₈O₃
- **CAS No:** 119-36-8
- **Synonyms:** Wintergreen oil, Benzoic acid, 2-hydroxy-, methyl ester
- **Recommended Use** Used as a flavoring agent, fragrance ingredient, in liniments and topical analgesics, and as an intermediate in organic synthesis.
