Section 1: Product Identification

- **Product Name:** Octyl Acetate
- **Chemical Formula:** C₁₀H₂₀O₂
- **CAS No:** 112-14-1
- **Synonyms:** Acetic acid, octyl ester, n-Octyl acetate
- **Recommended Use** Used as a flavoring agent, fragrance ingredient, and solvent in coatings and cosmetics.

Section 4: First Aid Measures

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Emits toxic fumes of carbon oxides under fire conditions.

- **Storage:** Store in tightly closed containers in a cool, dry, well-ventilated place. Protect from heat and light.

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents, strong acids and bases.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.
