Section 1: Product Identification

- **Product Name:** Ethyl 2-Methylbutyrate
- **Chemical Formula:** C₇H₁₄O₂
- **CAS No:** 7452-79-1
- **Synonyms:** 2-Methylbutanoic acid ethyl ester, Ethyl 2-methyl butyrate
- **Recommended Use** Used as a flavoring agent (apple, strawberry-like), fragrance ingredient, and solvent in organic synthesis.

- **Concentration:** >95%

Section 4: First Aid Measures
