Section 1: Product Identification

- **Product Name:** Ethyl Isobutyrate
- **Chemical Formula:** C₆H₁₂O₂
- **CAS No:** 97-62-1
- **Synonyms:** Isobutyric acid ethyl ester; Ethyl 2-methylpropanoate
- **Recommended Use** Used as a flavoring agent, fragrance ingredient, and solvent in organic synthesis.

- **Concentration:** >95%

Section 4: First Aid Measures

- **Inhalation:** Move to fresh air. If symptoms occur, seek medical attention.

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).

- **Stability:** Stable under normal conditions.
