Section 1: Product Identification

- **Product Name:** Ethyl Methylphenylglycidate
- **Chemical Formula:** C₁₂H₁₄O₃
- **CAS No:** 77-83-8
- **Synonyms:** Strawberry Aldehyde, Ethyl 3-methyl-3-phenylglycidate, Aldehyde C-16
- **Recommended Use** Used as a flavoring agent (notably strawberry-like), fragrance ingredient, and in cosmetics and personal care products.

- **Concentration:** >95%
