Section 1: Product Identification

- **Product Name:** Ethyl Nicotinate
- **Chemical Formula:** C₈H₉NO₂
- **CAS No:** 614-18-6
- **Synonyms:** Nicotinic acid ethyl ester; Niacin ethyl ester
- **Recommended Use** Used in pharmaceuticals, rubefacient preparations, and as an intermediate in organic synthesis.

- **Concentration:** >95%

Section 4: First Aid Measures
