Section 1: Product Identification

- **Product Name:** Ethylene Glycol Monobutyl Ether
- **Chemical Formula:** C₆H₁₄O₂
- **CAS No:** 111-76-2
- **Synonyms:** 2-Butoxyethanol, Butyl glycol, Butyl cellosolve
- **Recommended Use** Used as a solvent in paints, coatings, cleaning products, inks, and in industrial applications.

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Emits toxic fumes of carbon oxides under fire conditions.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid inhalation and skin/eye contact. Ensure adequate ventilation.
