Section 1: Product Identification

- **Product Name:** Furfuryl Mercaptan
- **Chemical Formula:** C₅H₆OS
- **CAS No:** 98-02-2
- **Synonyms:** 2-Furanmethanethiol, 2-Furylmethanethiol, Furfuryl mercaptan
- **Recommended Use** Used as a flavoring agent, especially in coffee, roasted, and savory notes, and in fragrances.

Section 4: First Aid Measures

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents, strong acids and bases.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.
