Section 1: Product Identification

- **Product Name:** Dimethyl Anthranilate
- **Chemical Formula:** C₉H₁₁NO₂
- **CAS No:** 85-91-6
- **Synonyms:** Anthranilic acid dimethyl ester; Methyl anthranilate
- **Recommended Use** Used in perfumery, flavorings (grape-like), and as an intermediate in organic synthesis.

- **Concentration:** >95%
