- **Product Name:** Dihydromyrcenol
- **Chemical Formula:** C₁₀H₂₀O
- **CAS No:** 18479-58-8
- **Synonyms:** 2,6-Dimethyl-7-octen-2-ol; 1,1,5-trimethyl-6-heptenol
- **Recommended Use** Used as a fragrance ingredient in perfumery, soaps, detergents, and personal care products.
