Section 1: Product Identification

- **Product Name:** Dihydro-Beta-Ionone
- **Chemical Formula:** C₁₃H₂₂O
- **CAS No:** 17283-81-7
- **Synonyms:** 4-(2,6,6-Trimethyl-1-cyclohexenyl)-2-butanone
- **Recommended Use** Used as a fragrance ingredient in perfumery, cosmetics, and as an intermediate in organic synthesis.
