Section 1: Product Identification

- **Product Name:** Diethyl Adipate
- **Chemical Formula:** C₁₀H₁₈O₄
- **CAS No:** 141-28-6
- **Synonyms:** Hexanedioic acid diethyl ester; Adipic acid diethyl ester
- **Recommended Use** Used as a plasticizer, solvent, and in cosmetics, personal care products, and organic synthesis.
