- **Product Name:** Dibenzyl Ether
- **Chemical Formula:** C₁₄H₁₄O
- **CAS No:** 103-50-4
- **Synonyms:** Oxybis(methylene)dibenzene; Benzyl ether
- **Recommended Use** Used as a solvent, plasticizer, and intermediate in organic synthesis.

- **Concentration:** >95%

Section 4: First Aid Measures
