Section 1: Product Identification

- **Product Name:** Decanenitrile
- **Chemical Formula:** C₁₀H₁₉N
- **CAS No:** 1975-78-6
- **Synonyms:** 1-Cyanononane; n-Decanenitrile
- **Recommended Use** Used as a fragrance ingredient, flavoring agent, and intermediate in organic synthesis.
