#### Section 1: Product Identification

- **Product Name:** Cyclopentanol
- **Chemical Formula:** C<sub>5</sub>H<sub>10</sub>O
- **CAS No:** 96-41-3
- **Synonyms:** Cyclopentyl alcohol; Hydroxycyclopentane
- **Recommended Use** Used as an intermediate in organic synthesis, and as a solvent and fragrance ingredient.
