Section 1: Product Identification

- **Product Name:** Grapefruit Mercaptan
- **Chemical Formula:** C₁₀H₁₈S
- **CAS No:** 71159-90-5
- **Synonyms:** 1-p-Menthene-8-thiol; 4-Mercapto-1-p-menthene
- **Recommended Use** Used as a flavor and fragrance ingredient, particularly in citrus and grapefruit-like formulations.

- **Concentration:** >95%

Section 4: First Aid Measures

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Emits toxic fumes of carbon oxides under fire conditions.

- **Appearance:** Colorless to pale yellow liquid
- **Odor:** Strong grapefruit-like odor

- **Molecular Weight:** 170.32 g/mol

Section 10: Stability and Reactivity

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents, strong acids and bases.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.

- **Routes of Exposure:** Inhalation, ingestion, skin and eye contact.
- **Acute Effects:** Causes skin and eye irritation. May cause respiratory irritation.
- **Chronic Effects:** Prolonged exposure may cause dermatitis and systemic effects.
