- **Product Name:** Guaiyl Acetate
- **Chemical Formula:** C₁₇H₂₈O₂

- **Synonyms:** Acetic acid, guaiyl ester; 2-Methoxyphenyl acetate derivative
- **Recommended Use** Used as a fragrance ingredient in perfumery, cosmetics, and personal care formulations.
