Section 1: Product Identification

- **Product Name:** Helvetolide
- **Chemical Formula:** C₁₇H₃₂O₃
- **CAS No:** 141773-73-1
- **Synonyms:** Methylcyclohexylidene acetates mixture
- **Recommended Use** Used as a fragrance ingredient in perfumery and personal care products.
