Section 1: Product Identification

- **Product Name:** Indole
- **Chemical Formula:** C₈H₇N
- **CAS No:** 120-72-9
- **Synonyms:** 1H-Indole; Benzopyrrole
- **Recommended Use** Used in perfumes, pharmaceuticals, and as an intermediate in organic synthesis.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Emits toxic fumes of carbon oxides under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.
