- **Chemical Formula:** C₅H₈O₂

- **Synonyms:** 4-Hydroxyvaleric acid lactone, 4,5-Dihydro-5-methyl-2(3H)-furanone
- **Recommended Use** Used as a solvent, bio-based chemical intermediate, and in flavors, fragrances, and fuel additives.
