- **Product Name:** Geosmin
- **Chemical Formula:** C₁₂H₂₂O
- **CAS No:** 19700-21-1
- **Synonyms:** Trans-1,10-dimethyl-trans-9-decalol
- **Recommended Use** Used in flavors, fragrances, and as a reference compound in water quality testing (earthy odor).

- **Concentration:** 95%

Section 4: First Aid Measures
