Section 1: Product Identification

- **Product Name:** Furaneol
- **Chemical Formula:** C₆H₈O₃

- **Synonyms:** 4-Hydroxy-2,5-dimethyl-3(2H)-furanone; Strawberry furanone
- **Recommended Use** Used as a flavoring agent in foods, beverages, and fragrances for its sweet, caramel-like odor.
