Section 1: Product Identification

- **Product Name:** Isoprenol
- **Chemical Formula:** C₅H₁₀O
- **CAS No:** 763-32-6
- **Synonyms:** 3-Methyl-3-buten-1-ol, Prenol
- **Recommended Use** Used as an intermediate in the synthesis of terpenoids, pharmaceuticals, and flavors and fragrances.

Section 4: First Aid Measures
