- **Product Name:** Ethyl Octanoate
- **Chemical Formula:** C₁₀H₂₀O₂

- **Synonyms:** Ethyl caprylate, Octanoic acid ethyl ester
- **Recommended Use** Flavoring agent, fragrance ingredient, and intermediate in organic synthesis.

- **Concentration:** >95%

Section 4: First Aid Measures

- **Eye Contact:** Rinse cautiously with water for several minutes. Seek medical attention if irritation persists.

- **Ingestion:** Rinse mouth. Do not induce vomiting. Seek immediate medical attention.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Vapors may form explosive mixtures with air. Emits toxic fumes of carbon oxides under fire conditions.

- **Personal Precautions:** Use personal protective equipment. Avoid inhalation and skin/eye contact. Ensure adequate ventilation.
