- **Product Name:** 2-Acetylpyrrole

- **Synonyms:** Methyl 2-pyrrolyl ketone

Section 4: First Aid Measures

- **Personal Precautions:** Use personal protective equipment. Avoid breathing vapors. Ensure adequate ventilation.
