Section 1: Product Identification

- **Product Name:** Acrolein
- **Chemical Formula:** C₃H₄O
- **CAS No:** 107-02-8
- **Synonyms:** 2-Propenal; Acrylaldehyde; Allyl aldehyde
- **Recommended Use:** Used as an intermediate in the manufacture of acrylic acid, methionine, and other chemicals; also used as a biocide.

- **Classification (GHS):** Flammable Liquid (Category 2), Acute Toxicity Oral/Inhalation (Category 2), Skin Corrosion (Category 1B), Eye Damage (Category 1).

- Highly flammable liquid and vapor
- Fatal if swallowed or inhaled
- Causes severe skin burns and eye damage
- May cause respiratory irritation

• **Precautionary Statements:**

- Keep away from heat, sparks, open flames, and hot surfaces
- Wear protective gloves, protective clothing, eye and face protection
- Do not breathe vapors
- Use only outdoors or in a well-ventilated area
- **IF IN EYES:** Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do – continue rinsing

Section 3: Composition / Information on Ingredients

- **Concentration:** >95%

Section 4: First Aid Measures

- **Inhalation:** Move to fresh air. If symptoms occur, seek medical attention.

- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical advice if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Seek medical attention if irritation persists.
- **Ingestion:** Rinse mouth. Do not induce vomiting. Seek immediate medical advice.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Emits toxic fumes of carbon oxides under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid inhalation and skin/eye contact. Ensure adequate ventilation.
- **Environmental Precautions:** Prevent entry into drains and waterways.
- **Cleanup Methods:** Absorb with inert material (sand, earth). Collect in suitable container for proper disposal.

Section 7: Handling and Storage

- **Handling:** Avoid inhalation of vapors and contact with skin/eyes. Use in well-ventilated areas.
- **Storage:** Store in tightly closed containers in a cool, dry, well-ventilated place. Protect from heat and light.

Section 8: Exposure Controls / Personal Protection

- **Exposure Limits:** Not specifically established for Acrolein.
- **Engineering Controls:** Ensure adequate ventilation and local exhaust systems.
- **Personal Protective Equipment:** Gloves, protective goggles, lab coat, respirator if exposure limits are exceeded.

- **Appearance:** Colorless to yellow volatile liquid
- **Odor:** Pungent, suffocating odor
- **Boiling Point:** 52 - 53 °C

- **Solubility:** Miscible with water, ethanol, and organic solvents
- **Molecular Weight:** 56.06 g/mol

Section 10: Stability and Reactivity

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents, strong acids and bases.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.

- **Routes of Exposure:** Inhalation, ingestion, skin and eye contact.
- **Acute Effects:** Causes skin and eye irritation. May cause respiratory irritation.
- **Chronic Effects:** Prolonged exposure may cause dermatitis and systemic effects.

- **Ecotoxicity:** Not classified as environmentally hazardous, but large releases may be harmful to aquatic organisms.
- **Persistence and Degradability:** Expected to be biodegradable under normal conditions.
