- **Product Name:** Allyl Octanoate
- **Chemical Formula:** C₁₁H₂₀O₂
- **CAS No:** 4230-97-1
- **Synonyms:** Octanoic acid, allyl ester; Allyl caprylate
- **Recommended Use:** Used as a flavoring agent and fragrance ingredient in food, beverages, and perfumes.

- **Stability:** Stable under normal conditions.

- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.
