Section 1: Product Identification

- **Product Name:** Alpha-Methyl Cinnamaldehyde
- **Chemical Formula:** C₁₀H₁₀O
- **CAS No:** 101-39-3
- **Synonyms:** 2-Propenal, 3-phenyl-2-methyl-; α-Methylcinnamaldehyde
- **Recommended Use:** Used as a fragrance ingredient in perfumes, cosmetics, and personal care formulations.

Section 2: Hazards Identification

- **Classification (GHS):** Skin Irritant (Category 2), Eye Irritant (Category 2A), Skin Sensitizer (Category 1).
- **Signal Word:** Warning
- **Hazard Statements:**

- Causes skin irritation
- Causes serious eye irritation
- May cause an allergic skin reaction

Section 3: Composition / Information on Ingredients

- **Concentration:** 100%

Section 4: First Aid Measures

- **Inhalation:** Remove to fresh air. If symptoms develop, seek medical attention.
- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical advice if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Get medical attention if irritation persists.
- **Ingestion:** Rinse mouth. Do NOT induce vomiting. Seek medical attention if unwell.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Dry chemical, foam, carbon dioxide (CO₂); water spray.

- **Specific Hazards:** Flammable liquid and vapor; vapors may form explosive mixtures with air; combustion may produce carbon oxides.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid breathing vapors. Ensure adequate ventilation. Eliminate ignition sources.
- **Environmental Precautions:** Prevent entry into drains and waterways.
- **Cleanup Methods:** Absorb with inert material (sand, earth). Collect in suitable container for disposal.

Section 7: Handling and Storage

- **Handling:** Avoid inhalation of vapors and contact with skin/eyes. Use with adequate ventilation. Keep away from ignition sources.
- **Storage:** Keep container tightly closed. Store in a cool, dry, well-ventilated place away from heat and oxidizing agents.

- **Exposure Limits:** ACGIH TLV 100 ppm (TWA); OSHA PEL 150 ppm (TWA).
- **Engineering Controls:** Provide adequate ventilation and local exhaust if needed.
- **Personal Protective Equipment:** Chemical-resistant gloves, safety goggles, protective clothing. Respirator if ventilation is inadequate.

- **Appearance:** Colorless to pale yellow liquid
- **Odor:** Sweet, floral, cinnamon-like odor
- **Boiling Point:** 148 - 149 °C
- **Flash Point:** 79 °C (closed cup)
- **Solubility:** Insoluble in water; soluble in ethanol and organic solvents
- **Molecular Weight:** 146.19 g/mol

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.
