- **Product Name:** Butyl Butyryl Lactate
- **Chemical Formula:** C₁₁H₂₀O₄

- **Synonyms:** Lactic acid, butyl butyryl ester

Section 3: Composition / Information on Ingredients

- **Concentration:** 100%

Section 4: First Aid Measures

- **Inhalation:** Remove to fresh air. If symptoms develop, seek medical attention.
- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical advice if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Get medical attention if irritation persists.
- **Ingestion:** Rinse mouth. Do NOT induce vomiting. Seek medical attention if unwell.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Dry chemical, foam, carbon dioxide (CO₂); water spray.
- **Specific Hazards:** Flammable liquid and vapor; vapors may form explosive mixtures with air; combustion may produce carbon oxides.

- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid breathing vapors. Ensure adequate ventilation. Eliminate ignition sources.
- **Environmental Precautions:** Prevent entry into drains and waterways.
- **Cleanup Methods:** Absorb with inert material (sand, earth). Collect in suitable container for disposal.

Section 7: Handling and Storage

- **Handling:** Avoid inhalation of vapors and contact with skin/eyes. Use with adequate ventilation. Keep away from ignition sources.
- **Storage:** Keep container tightly closed. Store in a cool, dry, well-ventilated place away from heat and oxidizing agents.

- **Exposure Limits:** ACGIH TLV 100 ppm (TWA); OSHA PEL 150 ppm (TWA).
- **Engineering Controls:** Provide adequate ventilation and local exhaust if needed.

- **Appearance:** Colorless to pale yellow liquid
- **Odor:** Mild, fruity odor

- **Solubility:** Slightly soluble in water; soluble in alcohol and organic solvents
