- **Product Name:** Hexyl Isovalerate
- **Chemical Formula:** C₁₁H₂₂O₂
- **CAS No:** 10032-13-0
- **Synonyms:** Isovaleric acid hexyl ester, Hexyl 3-methylbutanoate
- **Recommended Use** Used as a flavoring agent, fragrance ingredient, and solvent in organic synthesis.
