Section 1: Product Identification

- **Product Name:** Benzyl Cinnamate
- **Chemical Formula:** C₁₆H₁₄O₂
- **CAS No:** 103-41-3
- **Synonyms:** Cinnamic acid benzyl ester
- **Recommended Use** Used as a fragrance and flavor ingredient, fixative in perfumery, and in cosmetic formulations.
