Section 1: Product Identification

- **Product Name:** Methyl Heptanoate
- **Chemical Formula:** C₈H₁₆O₂
- **CAS No:** 106-73-0
- **Synonyms:** Heptanoic acid methyl ester
- **Recommended Use** Used as a flavoring agent, fragrance ingredient, and solvent in organic synthesis.

Section 4: First Aid Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
