- **Product Name:** Pentanoic Acid
- **Chemical Formula:** C₅H₁₀O₂
- **CAS No:** 109-52-4
- **Synonyms:** Valeric acid, n-Pentanoic acid
- **Recommended Use** Used in organic synthesis, pharmaceuticals, plasticizers, and as a flavor and fragrance ingredient.

Section 4: First Aid Measures
