Section 1: Product Identification

- **Product Name:** Lenthionine
- **Chemical Formula:** C₂H₄S₅
- **CAS No:** 292-46-6
- **Synonyms:** 1,2,3,5,6-Pentathiepane
- **Recommended Use** Naturally occurring organosulfur compound found in shiitake mushrooms; used as a flavoring agent with a characteristic sulfurous odor.
