- **Synonyms:** α-Dihydroionone, 4-(2,6,6-Trimethylcyclohex-2-en-1-yl)butan-2-one
- **Recommended Use** Used as a fragrance ingredient in perfumery, cosmetics, and flavoring formulations with woody, floral notes.
